

WYOMING PRESBYTERY SYNOPSIS
Stated Meeting of Presbytery
February 10-11, 2017
First Presbyterian Church, Saratoga, WY

The meeting was called to order by moderator, TE Jason Harshberger at 8:00 a.m. on February 10, 2017 at First Presbyterian Church, Saratoga, Wyoming.

Friday February 10th, 2017

Morning worship was led by Rev. Lynn Williamson with the message reflecting on a life of stewardship in the Church.

Several attendees shared sightings of the work of the spirit.

RE Jack Miller, of Loveland CO., led the day's workshop on "The Future of Church Philanthropy". Topics included:

Session 1. "**The current landscape of religious philanthropy**," membership challenges, getting people to increase their gifts of talent, and treasury.

Session 2. "**Creating a fun, yearly plan of generosity**" for your Church. Using the new tools of philanthropy in your Church for more generosity.

Session 3. "**Avoiding compliation**" Tracking giving, special appeals, the place for gift planning, creating a generosity plan to serve God and the church's mission.

Session 4. "**Who are your future leaders, who are your major donors**," what should we know about our members. Getting the congregation involved in a stronger church. Free tools to help you.

Sean Chow gave a presentation about the exciting life of faith in the 1001 Worshiping Communities program.

The clerk gave a brief presentation of the various Amendments to the Church Constitution coming to Presbytery as a result of actions by the 222nd General Assembly last June.

The Presbytery presented the Silver Spur to First Presbyterian Church of Cheyenne and Thomas Muhlbach and Norman Soden for their work with Living Waters International on projects in Central America.

Presbyters then broke into small groups to discuss the consent agenda and what items to pull for further discussion focusing notably on the proposed Amendments.
